Information on how to enter and prizes form part of these Terms and Conditions of Entry.

The Promoter: The Promoter is ALH Group, Level 2 10 Yarra Street, South Yarra 3141, ABN 68 098 212 134 owner / operator of the venues list in the appendices. (Participating Venues).

Duration of Promotion: The Promotion commences at 9AM AEST 02/11/18 and ends at 10pm AEST 04/11/18 ("the Promotional Period").
